




## **Coffs Harbour Holiday Unit**



## **Operation Hammersley**

On 28 February 1970 the Eighth Battalion, Royal Australian Regiment (8RAR) was in the middle of a strategically important operation against enemy Vietnamese forces in Phước Tuy Province, South Vietnam. In terms of casualties this is a sad day in 8RAR's history, as it was on this day that 8RAR lost nine soldiers and two supporting arms soldiers, killed in action.

Operation Hammersley, now commonly referred

to as the Battle of The Long Hais, began on 10 February 1970 when C Company, with tank, APC and mortar support deployed to the western side of the Long Hai Hills to protect quarry operations being undertaken by 17 Construction Squadron. C Company established Fire Support Base Isa near the quarry site and ambushed likely enemy routes leading from the hills. Within days of the commencement of the operation the entire

battalion was, at various stages, deployed to the area and over the ensuing days there were numerous contacts and major conflicts with enemy forces. Notable amongst these major contacts were 9 Platoon C Company's ambush of approximately one hundred enemy on the night of 15 February and C Company's 18 February assault on a major enemy troop concentration of D445 Battalion.

It was during the 18 February conflict with D445 Battalion that a mortar carrier with infantry passengers was hit by an RPG round and caught fire. A heavy battle followed and initial attempts to recover the mortar carrier failed; however, five of the seven mortar carrier occupants were rescued from the vehicle under heavy fire. For their part in this action, Corporal Barry Coe of C Company and Corporal Ronald Macey of B Squadron 3 Cavalry Regiment were each awarded the Military Medal. Sadly, both of these brave soldiers have since passed away.

During the ten days following 18 February numerous caches were discovered and more

than 200 enemy bunkers destroyed. 4 Platoon B Company achieved notable results during this period when ten of an enemy party of eleven were killed by the platoon or by the enemy's own mines while attempting to escape. Many enemy dead, killed during earlier fighting in this protracted battle, were found unburied.

Casualties suffered by 8RAR during Operation Hammersley to this time were very light, however, that changed on 28 February when a platoon from A Company was involved in two mine incidents. Prior to these incidents, the platoon had been moving at a rate of 100 metres per hour clearing a route to an ambush position. At 1100 hours an M26 grenade booby trap, with an anti-lifting device, was located. An engineer party moving to neutralize the booby trap triggered an M16 mine causing seven soldiers to be killed and 13 wounded. While guiding a helicopter into an area cleared of mines, a member of the platoon stepped out of the cleared area detonating a further M16 mine which killed one and wounded three soldiers. One of those

wounded in each incident later died.

The Long Hai Hills had for many years been a stronghold from which enemy provincial forces had operated with relative impunity against major centres of civilian population. From this stronghold the enemy, defended by mines and booby traps, had inflicted heavy casualties on forces that had attempted to dislodge them. 8RAR's operations had proved that it was possible to force large enemy groups out of their mountain hides and with modern tactics and a high fighting spirit, the battalion continued operations to destroy the enemy's "Minh Dam Secret Zone", causing heavy casualties to the enemy and repelling them from their sanctuary as well as capturing significant quantities of weapons and equipment, so that the local population could live in security.

8RAR was awarded the Meritorious Unit

Commendation, including Cross of Gallantry with Palm Unit Citation, by the South Vietnamese government for its involvement in Hammersley. Casualties during Operation Hammersley were 11 killed and 59 wounded. Of this number, two of the dead and 19 of the wounded were from supporting arms.

And so, it is that 28 February has come to be known as Long Hai Day and has become a significant day of commemoration for 8RAR. It is on this day each year that 8RAR remembers their mates who were killed on that day in 1970, and others of the battalion who were killed or died whilst serving during 8RAR's tours of duty in Malaysia and Vietnam, and those who have died subsequently.



# Thirtieth Anniversary of the United Nations Assistance Mission for Rwanda (UNAMIR) Reunion 21 – 26 April 2025



It's been 30 years since Australian Service Contingents 1 and 2 (ASC 1 and 2) were in Rwanda on Operation Tamar as part of UNAMIR II. The deployment of troops to Rwanda from 1994 to 1995 was a significant mission, with ASC 1 and 2 providing UN medical support.

A few members who served in Rwanda, with generous support from the Townsville RSL, have organised a reunion to commemorate this significant deployment and occasion. The reunion is for all UNAMIR contingents and will be held in Townsville, Queensland from 21 – 26 April 2025. This reunion invitation is extended to members of all UNAMIR contingents, not just 2/4RAR and 2RAR members. The culmination of the reunion will be the Townsville Anzac Day march at The Strand, where the Rwanda Reunion Contingent will be the lead veteran group. Townsville RSL are generously providing a specific banner for the Rwanda veterans to march under.

Support by the Townsville RSL has enabled the reunion to be a low-cost affair. The only cost will be for food at the reunion dinner on 23 April. There will be no facility, equipment hire or security costs to

#### **Veterans to Better Access Hearing Support**

Monday, 20 January 2025

More than 10,000 Australian veterans will this year be more empowered when it comes to hearing health, with significant improvements to how the government supports those with hearing impairment. Hearing loss and tinnitus are some of the most common conditions resulting from military service. These conditions affect individuals differently, at times it can be frustrating and isolating, affecting a person's overall health and wellbeing.

The government acknowledges those who have long advocated for improved hearing support for veterans, to improve their quality of life. Now, veterans experiencing hearing impairment will

have better access to a variety of hearing aids and supports through the Department of Veterans' Affairs' – Veteran Hearing Services Framework. With a renewed focus on supporting overall wellbeing and quality of life, the Framework considers the broader implications of hearing impairment for each individual – including for their health, social support and connection and employment and volunteer work, to ensure Australia's veterans receive the practical hearing support they need, when and how they need it. This will also speed up requests for complex hearing conditions while improving information available to veterans, families and service providers.

The public are invited to provide comment on the planned Nuclear-Powered Submarine Construction Yard Draft Strategic Impact Assessment Report for

Osborne, South Australia.

The public consultation period will run from 3 February to 17 March 2025.

Australia will begin the build of its fleet of conventionally armed, nuclear-powered SSN-AUKUS submarines at Osborne by the end of this decade. To facilitate the build of SSN-AUKUS, the Nuclear-Powered Submarine Construction Yard will enable Osborne to become one of the most advanced technological hubs in the world and help meet our long-term defence needs.

The Australian Submarine Agency (ASA) has worked closely with the Department of Climate Change, Energy, the Environment and Water to progress a Strategic Assessment under Part 10 of the *Environment Protection and Biodiversity* Conservation Act 1999, culminating in the development of this Draft Report. The Draft Report outlines measures to be taken to mitigate potential impacts on Protected Matters, as a result of the construction and operation of the Yard and includes findings from environmental assessments undertaken as part of the process.

# Festival of Veterans Arts coming to Melbourne in March

28 January 2025

The Australian National Veterans Arts Museum (ANVAM) has unveiled the official program for the second annual Festival of Veterans Arts (FOVA25). Following a successful debut in 2024, FOVA will offer an even wider selection of veteran and public events under this year's theme, "TOGETHER", highlighting creativity as a unifying force for veterans, families, and the community.

FOVA will run from 21 to 30 March 2025, in Melbourne's Southbank and Arts Precinct.

In 2024, FOVA's inaugural year welcomed 600 attendees and featured 109 veteran artists and contributors across 25 events. FOVA25 builds on that foundation, offering a broader, more inclusive program with a focus on fostering connection and sharing veterans' creative journeys with the public.

Key public events taking place include:

- FOVA Family Colour Parade Instead of watching parades from the sidelines, the FOVA Family Colour Parade invites the community in full colour to be the parade led by a marching band.
- Art exhibitions Including March to Art, Victoria Barracks art exhibition, Home Front and Veterans Public Arts Trail
- Variety performance and live music –
   Showcasing the talent and creativity of veterans through their own captivating stage performances and live music
- Live music and Last Post Service Honouring those who served, with music and reflection.

There are also events only for the veteran community:

- Summit Insightful panels and discussion on the arts and the veteran community
- Creative workshops Opportunities to engage in visual arts, music, writing, and more, led by veteran artists and open exclusively to current and ex-ADF veterans and families.
- Open house at Waller House A private

opportunity to explore the iconic home of Napier and Christian Waller, Victorian artists who created cultural landmarks across Melbourne.

Mervyn Napier Waller was seriously wounded in 1917 at fighting in Bullecourt. His right arm was amputated at the shoulder and, during his convalescence, he learned to draw and write with his left hand. He later established a reputation as a creator of large-scale murals and mosaics. He is honoured by the Napier Waller Art Prize, which is awarded every two years, and judged by art professionals from the Australian War Memorial.

#### 2025 Australia Day **Honours**

26 January 2025

ADF members from across the land, maritime, air, cyber and space domains have been recognised with military awards in the 2025 Australia Day honours list. The full list of 2025 Australia Day Military Awards can be seen here.

Among the Australians honoured is Chief Petty Officer Matthew Lee Ostrowski, for meritorious achievement in support of the Collins Class Submarines. After heavy metals were detected seeping into drinking water aboard Collins Class submarines, Chief Petty Officer Matthew turned his office into a laboratory so he could quickly find a solution. He discovered a type of filter that could remove nickel and cadmium leaching from weld joints in the boat's pipes, eliminating the need to carry hundreds of litres of bottled drinking water on the already cramped submarines and potentially saving millions in repair costs.

It's what earned the UK-native a Conspicuous Service Medal as part of the 2025 Australia Day Honours. After creating a laboratory in the office where he could quickly test submarine water samples, he found a contractor who could supply filters to remove the heavy metals. Previously, there was a two-week wait to test water as it was sent off site. Chief Petty Officer Matthew and team then trialled different filters until he found one that worked, collecting and testing hundreds of samples along the way.

"We were looking at changing the pipe work because this contamination was coming from the welds throughout the pipes and tanks," Chief Petty Officer Matthew said.

"The remediation package would have been really intrusive, very expensive and it would have taken a lot of time. This was, you know, an easy, quick, simple fix in the end."

It's Chief Petty Officer Matthew's 26<sup>th</sup> year of service, first with the Royal Navy and now the Royal Australian Navy. He said to be recognised and honoured in this way was a memorable personal achievement. "To get that sort of recognition after you dedicate your life to something is huge," Chief Petty Officer Matthew said. "But I'm cognisant of the fact it wasn't just me. I'm happy for the recognition for spearheading the concept but I wouldn't have been able to do it without the rest of the team."



### Navy Leads Brumbies to Water

Navy continues its support to elite Australian sporting teams, hosting the ACT Brumbies for a weeklong pre-season training camp at HMAS Creswell. HMAS Creswell physical training instructors (PTIs) led the Brumbies on teamwork and leadership challenges designed to test the physical and mental limits of the players.

Chief Petty Officer PTI Kristian Weldon said the focus was on building teamwork, resilience and trust within the team. "By engaging in handson tasks that require collaboration and mutual support, we've strengthened their ability to work together as a team," Chief Petty Officer Weldon said. "Encouraging everyone to rely on one another and

develop deeper connections has been invaluable."

Chief Petty Officer Weldon also underscored the broader benefits of physical training and team building for the body and mind. "Team building and physical fitness play a crucial role in enhancing mental health and overall wellbeing," he said. "Fostering stronger connections within our teams, promoting resilience and encouraging active lifestyles can significantly reduce stress, boost mood and improve mental clarity. This leads to a healthy mind-body balance and can enhance longterm wellbeing."

This unique view of physical training and team building shines a light on the lesser known or sometimes overlooked benefits of exercise, like

improved cognitive function and general wellbeing.

Captain of the Men's Super Rugby team, Allan Alaalatoa, said the camp was excellent.

"The PTIs ran some great team-building exercises that allowed us to strengthen our bonds and communication," he said. "The facilities and location are next level. I thought it was a perfect way to start our year."

The Brumbies weeklong training camp involved serials on the picturesque HMAS Creswell quarterdeck, in the gym and pool, as well as training and recovery sessions on Hyams Beach.
